#### **Explanation of Responses:**

- 1. Consists of 18,335 restricted stock units ("RSUs"), 2,663 of which have vested. 7,683 RSUs will vest on March 4, 2021, subject to the Reporting Person's continued service to the Issuer. All other unvested RSUs will vest in semi-annual installments, subject to the Reporting Person's continued service to the Issuer, beginning on February 15, 2021 and ending on August 15, 2023.
- 2. This option represents a right to purchase a total of 21,305 shares of the Issuer's common stock, one quarter of which vested on June 12, 2020, with the remaining three quarters vesting in equal annual installments over the following three years, subject to the Reporting Person's continued service to the Issuer.
- 3. This option represents a right to purchase a total of 7,683 shares of the Issuer's common stock and will vest in full on March 4, 2021, subject to the Reporting Person's continued service to the Issuer.
