- 1. Consists of 22,256 restricted stock units ("RSUs"), 5,564 of which will vest on May 15, 2021. The remaining RSUs will vest in semi-annual installments beginning on November 15, 2021 and ending on May 15, 2024, subject to the Reporting Person's continued service to the Issuer.
- 2. This option represents the right to purchase a total of 44,512 shares of the Issuer's common stock, one quarter of which will vest on April 15, 2021, with the remaining three quarters vesting in equal monthly installments over the following three years, subject to the Reporting Person's continued service to the Issuer.
